

## February 15, 2025, Convention Minutes

**1. Call to Order.** Conner Tranquill called the convention to order at 9:00 p.m. on February 15th, 2025.

## 2. Officer Reports.

- **a. Chairman's Report.** Conner Tranquill updated the convention on the activities of the federation over the last year and highlighted the upcoming proposed rule change at the OK GOP convention.

- **b. Director of Budget and Internal Finance (DBIF).** No candidates filed for DBIF, and no nominations were made from the floor. The State Committee will adopt a new schedule for electing the DBIF prior to the expiration of the term
- **c. Vice Chairman.** Anthony Diulio was elected Vice Chairman by acclamation.
- d. Chairman. Conner Tranquill was elected Chairman by acclamation.
- 6. OKFCR Constitutional Amendments.



- **a. Treasurer Amendment.** The amendment submitted by Conner Tranquill, seconded by Parker Crawley, was adopted unanimously.
- **7. OKFCR Platform.** The platform presented by Conner Tranquill, seconded by Gabriela Dimova, was adopted with four votes in favor with one abstention.
- **8. Other Business.** Delegates were reminded by Conner Tranquill and Parker Crawley of the importance of attending the OK GOP Convention (tentatively scheduled for May 2-3rd) to show our activity and involvement to the whole state.
- **9. Adjournment.** The convention was adjourned at 9:41 p.m., February 15th, 2025, by Conner Tranquill.
